RE: Cooperative Agreement between Cochranton High School & Commodore Perry High School

To Whom It May Concern:

In accordance with Article III, Section II of the PIAA Bylaws, Commodore Perry School District and Crawford Central School District (Cochranton High School) will be entering into the following cooperative agreements during the 2016-17 enrollment classification cycle.

- Baseball (hosted by Cochranton High School)

The implementation of this agreement will occur on Monday August 15, 2016 at the beginning of the fall sports season. The addition of Commodore Perry athletes will not change the classification of Cochranton High School for scheduling purposes.


The name of the teams will be the Cochranton Cardinals, and the uniforms will be those of Cochranton High School.

Commodore Perry School District will pay Crawford Central School district at a rate of \$500.00 per Commodore Perry Athlete. The number of athletes will be determined based upon the number of Commodore Perry athletes currently on the roster following the 5<sup>th</sup> regular season game.

All operations of the team and staff including uniforms, facilities, coaches, and insurance will be managed by the administration of Cochranton High School.

Transportation of Commodore Perry athletes to practice will be the responsibility of the individual athlete. Transportation to scrimmages and games will be the responsibility of Cochranton High School with the departure to occur at their high school facility. Commodore Perry athletes will provide their own transportation to Cochranton to attend games and scrimmages except in situations in which the bus will pass Commodore Perry High School en route to a game.
